Guidance notes for completing the transfer application form

IDS' transfer lists operate on a 'Date of Entry Basis'. We will process your application in accordance with the information you give on this form and you will enter the list from the date we receive your correctly completed application at Head Office. We will not alter that information unless you tell us to.

It is important that you tell us about any changes in your household or circumstances, as this may affect what property you are eligible for. If your record is inaccurate because you have failed to inform us of changes you may waste time climbing the wrong list and extend the time you will have to wait for an appropriate transfer offer. If you wish to inform us of anything not covered by this form, please attach a separate note. Please note the only method used for prioritising transfer applications is the date of acceptance of the application.

Note 1: Your Name

This should be the name of the IDS tenant who is applying for transfer. In the case of a joint tenancy the names of both tenants should be entered.

Note 2: Household Details

List details of everyone who lives with you. Please note that the only persons IDS will automatically accept responsibility for the housing needs of are: the persons named on the original tenancy agreement; children born to the tenant during the tenancy; persons IDS has previously agreed with the tenant to consider authorised members of the household.

Note 3: Accommodation Preferences and size

You may apply for all sizes within your range of eligibility but you should take care not to apply for sizes that you do not qualify for as you will not be offered a property that is not the right size for your household.

Note 4: Estate Selection

You may tick as many schemes as you wish that have property within your size eligibility. The more schemes you are prepared to consider the quicker you are likely to receive an offer.

Note 5: Sheltered Housing

Sheltered housing is independent living accommodation for persons over 60 years of age, or for those that have a disability that means you need the support that the scheme offers. The accommodation benefits from a warden call system and communal social facilities.

Other Options:
